

### PFAS Remark :

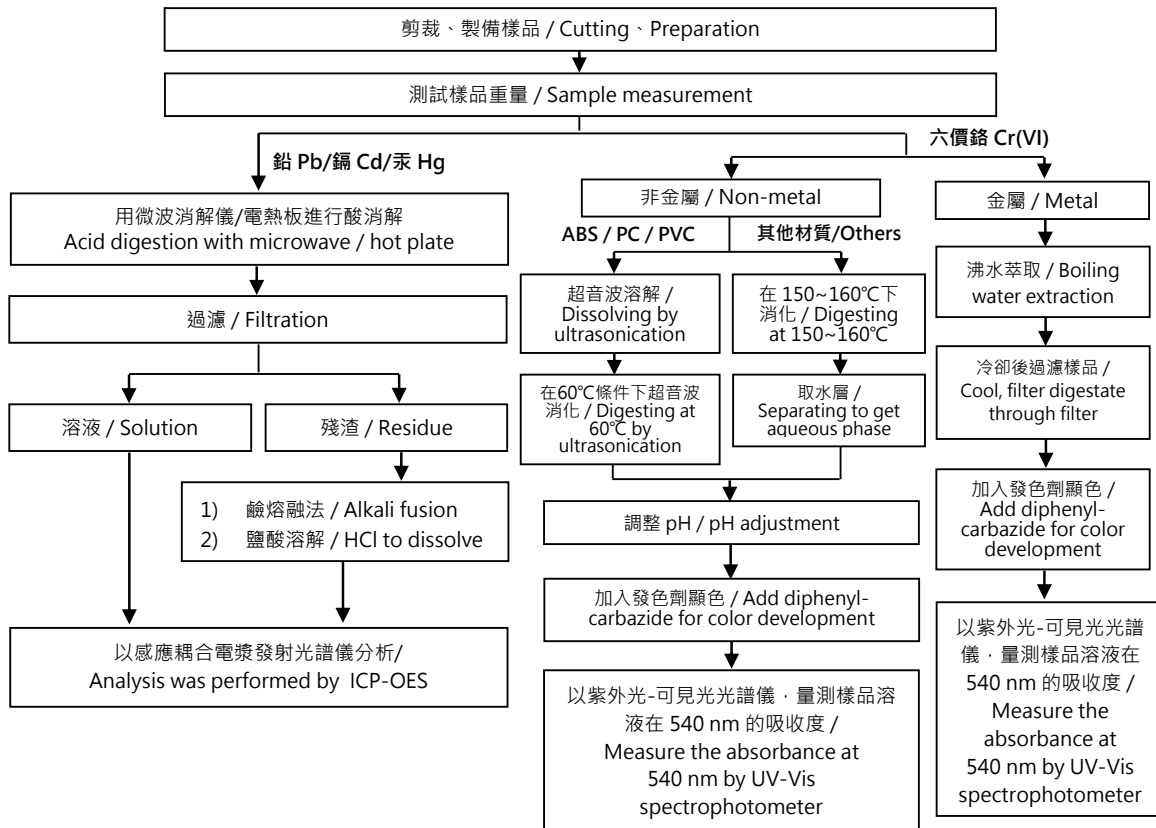
